Letter from THE PRESIDENT

We began the 2022-2023 academic year bidding goodbye to our old friend, the training ship Empire State VI. Cadets, alumni, faculty, and staff gathered on October 5, 2022 to watch the ship as she made her way under the Throggs Neck Bridge for the last time to Long Island Sound en route to Brownsville, Texas, for scraping. It was a bittersweet moment to witness the departure of a vessel that helped prepare generations of cadets in their future careers in the maritime industry. However, her departure allowed the start of a major \$40 million pier construction project in preparation for the arrival of Empire State VII, which was launched in Philly Shipyard in late September.

Throughout the year, Maritime College continued to improve in its national recognition and rankings as a public institution of higher education. Once again, *Money Magazine* listed Maritime College as one of the 10 Best Colleges in New York State. This top ranking comes at a time when families and potential students consider the costs associated with attending a college or university and the benefits of completing a higher education degree. *Money’s* annual college rankings highlighted the colleges where students receive a quality education for a comparatively affordable price. In their ranking, *Money* indicated that virtually all graduates of Maritime College find work within a few months of graduation, and the typical salaries of graduates are well above average. Additional national ranking information is available in the pages to follow.

An education at Maritime College is not without its expenses and many students (regimental and civilian) are in need of financial assistance to successfully complete their degree programs. The Admiral’s Scholarship Dinner is the single largest annual donor event, and 2022 was no exception as donations exceeded the \$700,000 level. Over 500 Maritime College alumni and friends attended the event to raise much-

needed scholarship funds for Maritime students. The Dinner was also an opportunity to celebrate industry leaders Kevin Collins ’96, Partner at MCA Associates; Boriana Farrar, VP and Chief Legal Officer at Patriot Contract Services LLC; and WISTA USA (Women’s International Shipping & Trading Association).

Most notably, we entered our sesquicentennial anniversary in April 2023 with an engaging video message that focuses on the theme, Celebrating Our Past | Investing in Our Future. Investing in people and programs is critical to ensure that Maritime College continues to deliver top talent to a unique industry – an industry that needs graduates who are well prepared to meet the challenges of an increasingly changing world.

SUNY Maritime Foundation has been generous in supporting our students, academic programs, and emerging needs and opportunities. I would also like to recognize the generosity of each of the donors listed in this Annual Report. Your continued support is essential and I thank you for contributing toward student success!

Please enjoy the highlights of another great year at Maritime College contained in this Annual Report.

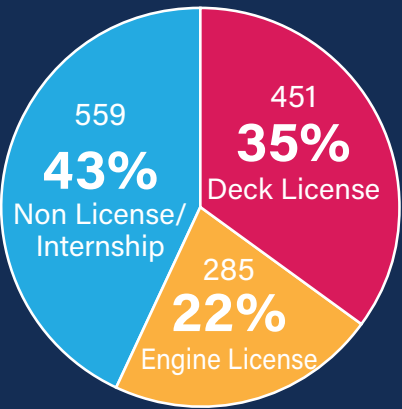

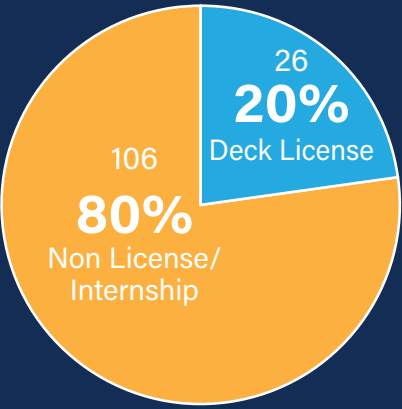

MARITIME COLLEGE BIDS FAREWELL TO TRAINING SHIP EMPIRE STATE VI

On October 5, many gathered at the pier to bid their final farewell to the Empire State VI as it left the pier that cloudy morning. MUGs who watched from beyond the pier noted that, although they did not have an opportunity to sail on the Empire State as first year cadets, they wanted to be present for the important occasion of the ship's final departure from Fort Schuyler.

Throughout its years at Maritime College (since 1990), the TSES VI has been utilized to train and prepare thousands of cadets for careers within the global maritime industry. It will always be known to many as the vessel that effectively served its purpose by providing generations of mariners with the hands-on training and experience that is at the core of the Maritime College mission.



FACULTY IN THE NEWS

DR. CATERINA PANZECA

The November/December 2022 issue of *WindCheck Magazine* featured Marine Environmental Science (MES) professor, Dr. Caterina Panzeca, and Maritime MES students who participated in a water quality study on the Long Island Sound. They were among twenty-five groups that collected data for the Unified Water Study, launched by Save the Sound in 2017. Their purpose was to monitor the ecological health of the bays and harbors around Long Island Sound.

As part of the study, groups collected two tiers of data. The first tier will be reflected in the Bay Grades section of the biennial Long Island Sound (LIS) Report Card, a visual representation of those data points converted into a useful tool for scientists, environmental groups, students and members of the community. For Dr. Panzeca's research-oriented Marine Environmental Science class, the LIS Report Card has been a reliable resource and effective teaching tool in the class.

DR. JENNIFER WATERS

Provost and Vice President of Academic Affairs, Dr. Jennifer Waters, was called upon by various news outlets to share her expertise regarding the Titanic Submersible that went missing in the North Atlantic Ocean in June. Dr. Waters, an ocean engineer, naval architect and academician, appeared in various television interviews with NYC's *Eyewitness News*. She was also featured in news articles with *The New York Times*, *The Washington Post* and *Wired*. Her interviews involved discussions concerning the purpose of a remotely operated vehicle that was launched to search for the missing submersible with five individuals on board.

CAPTAIN MORGAN MCMANUS '92



Captain Morgan McManus, Master of the Training Ship Empire State VII, was invited to speak with *The Star Ledger* in July regarding a deadly fire that erupted on a cargo ship in Port Newark, NJ. His expertise focused on the difficulty of fighting shipboard fires and he offered insight concerning whether municipal fire departments – which often do not encounter such incidents – are prepared and trained to effectively respond to shipboard fires.

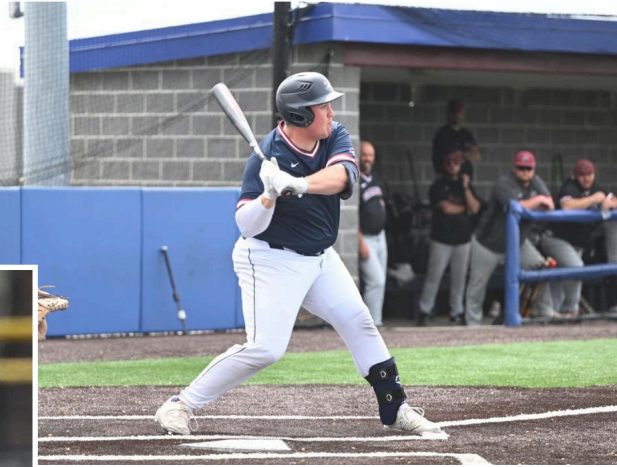


Fire burned on the Grimaldi vehicle carrier Grande Costa d'Avorio in Newark for five days.

A HISTORIC ATHLETIC SEASON

The 2022-2023 athletic season resulted in one of, if not the most, successful years in the history of the Maritime College athletics program. Eight out of the College's eleven Skyline Conference competing programs finished in the top four of the Conference. Among the highlights of the Privateers athletics year include:

- Men's Lacrosse completed the regular season #1 in the Skyline Conference. The team beat a nationally ranked team and has not lost a regular season Conference game in five years.
- Women's Lacrosse finished the regular season with the most wins in program history and reached the Skyline Championship for the first time.
- Baseball achieved the most wins in program history and reached the Skyline Championship.
- Men's Basketball accomplished a 10-0 home record in the Conference, finished with the highest seed in program history, and won a playoff game for the first time.
- Men's swimming had an individual qualify for the Eastern College Athletic Conference tournament for the first time.
- Women's Diving set school records.
- Sailing was ranked 11th in the country going into Nationals-their highest ranking ever.
- Women's Cross Country tied for the best finish in program history.
- Eight out of the College's eleven Skyline competing programs finished in the top four of the Conference.
- Three of the eight teams made it to the Championship game.
- Four of the eight teams won a Skyline Conference playoff games.
- Three of the College's Head Coaches were named Conference Coach of the Year.



FABRICATING THE FIRST NATIONAL SECURITY MULTI-MISSION VESSEL (NSMV): 2022-2023

The first NSMV, a world-class training ship, is a historic milestone for the maritime industry and Maritime College. Construction began in 2020 and continued through Spring 2023. The state-of-the-art, multi-mission vessel, which was christened Empire State, will be used to train the next generation of merchant mariners.

On September 24, the newly constructed Training Ship Empire State VII was launched at Philadelphia Shipyard. The new training ship was gently guided into its new berth by McAllister Towing tugs.

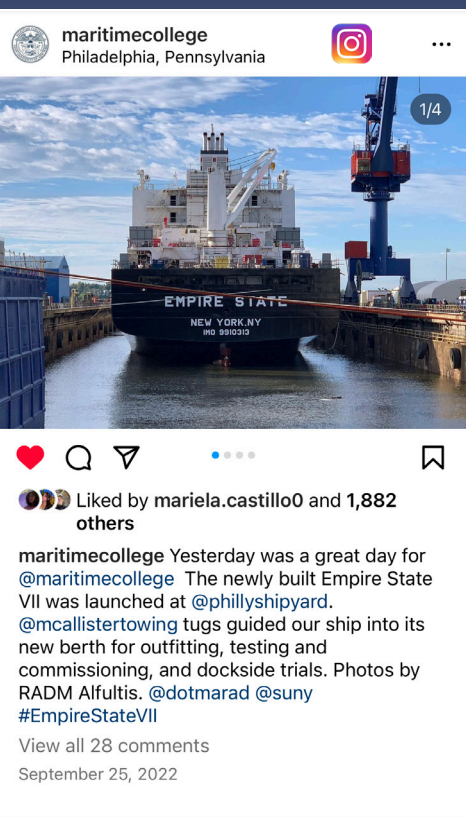

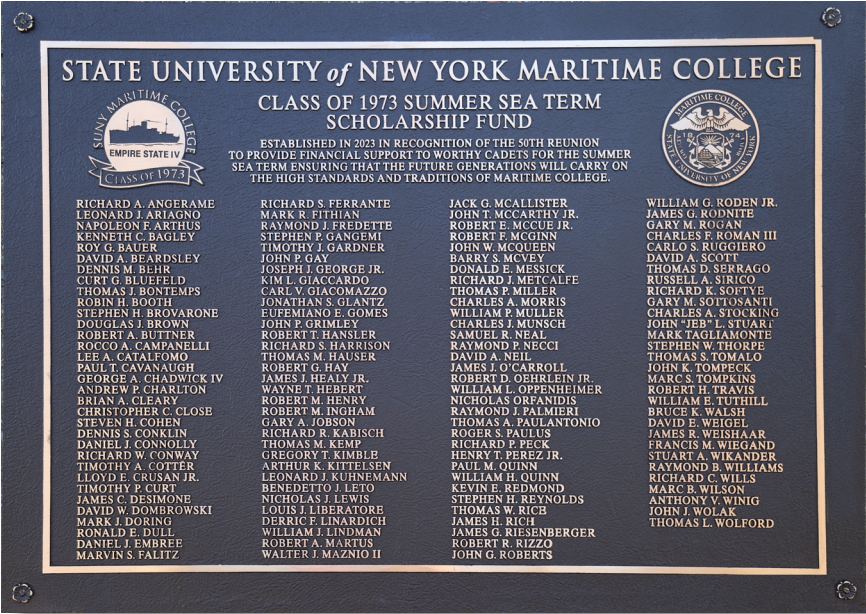

Congratulations to the Class of 1973 on celebrating their 50th reunion. In the two years leading up to their reunion, the Class worked to establish an endowed scholarship fund and contributed \$124,000 by June 30, 2023, . The Class of 1973 Endowed Scholarship Fund will help defray the cost of a Summer Sea Term (SST) by providing partial scholarships for one Deck and one Engine student each year in perpetuity.

The Class of 1973 is the most recent class to earn a plaque on SUNY Maritime College Sea Wall, which memorializes the esteemed classes that raise \$100,000 or more toward an endowed fund through the SUNY Maritime Foundation. “The College is deeply grateful for this class’s unwavering commitment to giving back to their alma mater. This success is not just about raising money; it’s about Fort Schuyler alumni coming together



to make a meaningful impact on the lives of the next generation of Fort Schuyler graduates,” said Admiral Alfulitis.

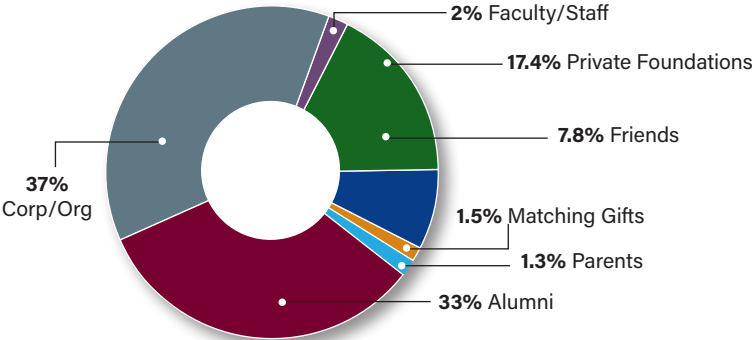
Endowed gifts may be designated by the donor(s) to support scholarships, Dean’s Funds, faculty initiatives, or student programs, investments that drive Maritime’s progress for centuries to come. The Foundation also appreciates unrestricted endowed gifts that the College may use to address the greatest needs or pursue unanticipated opportunities.

Note: Endowments are professionally managed for the SUNY Maritime Foundation by J.P. Morgan with a goal of producing ~4% spendable return annually. The additional earnings are retained and reinvested to ensure the principal grows so that the spendable return keeps pace with inflation.

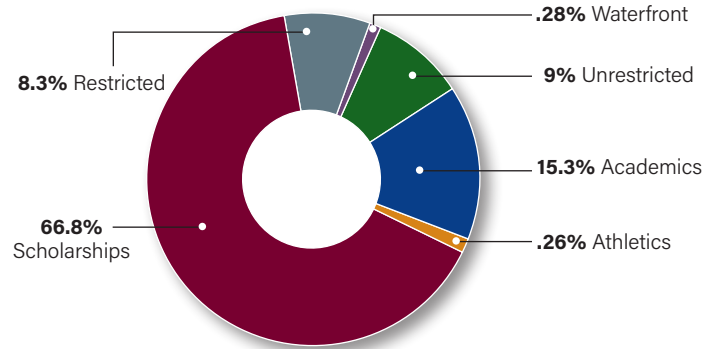

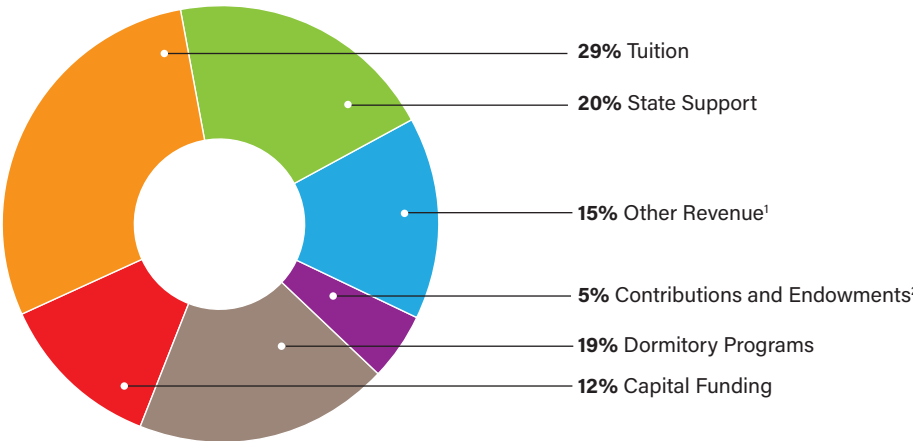
BRUCE S. ROSENBLATT ASSOCIATES ENGINEERING SCHOLARSHIP

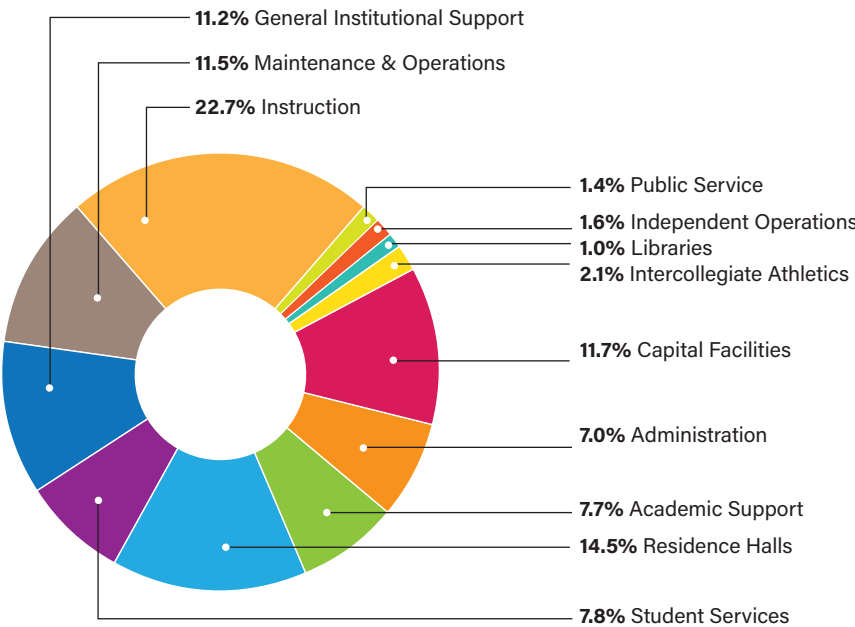
